### Document required for reserve category students

### Government of India Post SSC Scholarship/Freeship for SC, ST, DT, NT, OBC and SBC **(OBC Freeship is not applicable for Self Financing Courses)**

- SC, ST, DT, NT, OBC and SBC students are required to produce following documents at the time of admission:
  1. Attested copy of the caste certificate in the name of the student issued by Maharashtra State and that caste should be in the Maharashtra State list.
  2. Attested copy of Income certificate of parents.
  3. Attested copy of the Ration card (first and last page only)
  4. Attested copy of the Mark sheet.
  5. Continuation Scholarship Students (Navi Karan) who have already received scholarships are not required to renew their Income-certificate.
  6. Photocopy of Union Bank Pass Book in the student's name to be submitted.
  7. Photocopy of Aadhar Card
  8. Domicile Certificate
  9. **FOR SCHOLARSHIP :-**
    - (i) Students belonging to SC and ST whose parents gross income is within the limit of Rs.2,00,000/- p.a. are eligible to apply for Post SSC Scholarship. **(Income Certificate certified by the Tahsildar Office has to be submitted at the College office counter)**
    - (ii) Students belonging to DT, NT, OBC and SBC whose parents gross income is within the limit of Rs.1,00,000/- p.a. are eligible to apply for Post SSC Scholarship. **(Income Certificate certified by the Tahsildar Office has to be submitted at the College office counter)**
  10. **FOR FREESHIP :-**
    - (i) Students belonging to SC and ST whose parents gross income is above Rs.2,00,000/- p.a. are eligible to apply for Freeship. **(Income Certificate along with Form No. 16 to be submitted at the college office counter)**

### NOTE:

1. Students of S.Y. & T.Y. Classes will be given Government Scholarships/ Freeships Forms 2<sup>nd</sup> week of July and the date of submission for the same will be last week of July 2019.
2. The student who does not submit the Caste & Income certificate at the time of submitting the application form for admission will automatically be considered under open category.

### RULES:

- (i) Students belonging to SC and ST whose parents gross income is within the limit of Rs.2,00,000/- p.a. are eligible to apply for Post SSC Scholarship. **(Income Certificate certified by the Tahsildar office)**
- (ii) Students belonging to SC and ST whose parents gross income is above Rs.2,00,000/- p.a. are eligible to apply for Freeship. **(Income Certificate alongwith Form No. 16)**

**Reserve Category students need to submit all relevant documents at the time of the admission. If there is any discrepancy during the submission, the students will have to pay the full fees, which will be refunded on getting the approval from the relevant government authority**
